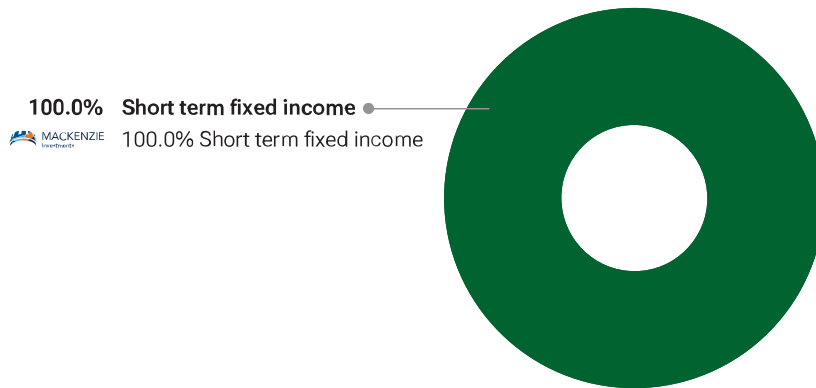

Neutral portfolio allocation¹



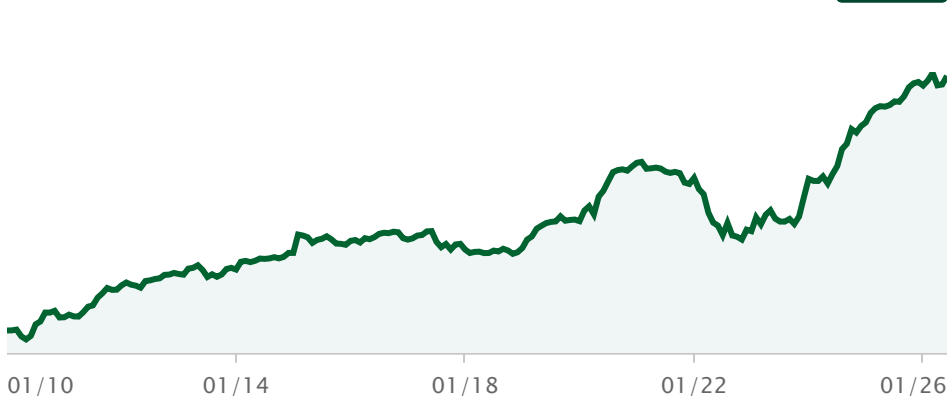

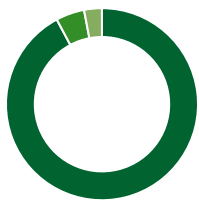

Q1 2026 Fund Commentary

Market Commentary

The first quarter of 2026 brought a volatile mix of geopolitical friction in the Middle East and a technology-driven growth narrative in the United States. The period began with optimism after the resolution of the U.S. federal government shutdown, but sentiment shifted as tensions between the U.S. and Iran escalated. Energy price volatility introduced competing forces for fixed income markets – inflationary pressure from rising oil prices weighed against the deflationary risk of a broader growth shock.

In Canada, the economic picture diverged from the U.S. as domestic fragilities became more apparent. The Bank of Canada (BoC) held its benchmark overnight interest rate steady at 2.25% in March, though policymakers adopted a more cautious tone. Data confirmed that the Canadian economy contracted in the final quarter of 2025, and the labour market showed signs of cooling, with the unemployment rate rising to 6.7% in February.

Performance

The Fund's allocation to maturities across the Canadian yield curve contributed to performance. An underweight position in shorter-term Canadian rates also contributed during the quarter. Canada's economic outlook diverged from the U.S. as growth weakened and the labour market cooled, prompting markets to reassess the BoC's policy path. While Canadian yields moved higher, the Fund's curve positioning captured relative value opportunities during the period.

The Fund's allocation to bonds in the financials sector detracted from performance. A holding in Sun Life Financial Inc. (2.80%, 2033/11/21) bonds detracted from performance during the quarter. Bonds within the financials sector underperformed the benchmark during the period, weighing on relative returns.

Portfolio Activity

The sub-advisor added to the Fund a holding in ARC Resources Ltd. (3.349%, 2029/02/25) bonds during the quarter, participating in the company's new issue. ARC Resources is one of Canada's leading natural gas and liquids producers, with a strong asset base and disciplined capital allocation. The addition aligns with the sub-advisor's constructive outlook on Canadian energy and reflects confidence in the issuer's credit profile.

The sub-advisor increased the Fund's exposure to Canadian Core Real Estate LP (4.482%, 2029/10/16) during the quarter. Canadian Core Real Estate owns a diversified portfolio of commercial and residential properties across Canada, with assets concentrated in core urban markets and supported by stable rental income. The increased allocation reflects the sub-advisor's comfort with the credit given the issuer's conservative leverage profile and defensive cash flows.

The sub-advisor sold a holding in Canadian Imperial Bank of Commerce (6.369%, 2085/04/28) during the quarter as part of ongoing adjustments to Fund exposure to limited recourse capital notes (LRCN). The exit forms part of the sub-advisor's broader portfolio rebalancing efforts aimed at maintaining appropriate LRCN exposure and managing duration risk, while creating flexibility to redeploy into more attractive opportunities.

The sub-advisor reduced the Fund's position in Province of Ontario (1.35%, 2030/12/02) bonds during the quarter to align the Fund's duration and asset allocation objectives.

Outlook

The sub-advisor is maintaining a long front-end bias in Canada. In the sub-advisor's view, Canada may be entering a housing-led downturn, where a combination of falling rents and tighter financing could prompt the BoC to reduce interest rates toward the middle of 2026.

In the U.S., the sub-advisor's positioning of the Fund was more tactical. The sub-advisor began the year with an underweight duration but moved to neutral as the Middle East conflict escalated. In mid-March, the sub-advisor selectively added to the Fund long duration in 10-year and 30-year U.S. Treasuries as a hedge against an escalation-driven growth shock, though resilience in core inflation measures may limit the U.S. Federal Reserve Board's ability to ease monetary policy in the near term.

Within credit, the sub-advisor is maintaining an overweight in investment-grade corporate bonds. In high yield, the sub-advisor continues to favour the aerospace and defence industry because of an environment of increased fiscal defence outlays. The Fund is underweight in the automotive and airline sectors because of execution risks and the direct impact of higher jet fuel costs. In the energy space, the sub-advisor believes the stability of Western Canadian infrastructure may provide an advantage as insurance and shipping costs rise in more volatile regions.
