

Counsel High Interest Savings Fund Series I

The fund is designed to provide investors with a high rate of monthly interest income, while preserving capital and providing liquidity, by investing primarily in high interest deposit accounts. The effective interest rate earned by unitholders may vary from the gross rate provided to the fund due to uninvested assets to facilitate unitholder transactions and expenses. The fund seeks to maintain a constant net asset value of \$10 per security.

Is this portfolio right for you?

- May provide higher interest than traditional savings accounts. Currently, the gross interest rate paid to the fund is 2.27% based on the deposits held by the Fund. The effective interest rate earned by unitholders may vary from the gross rate provided to the Fund due to uninvested assets to facilitate unitholder transactions and expenses.²
- Alternative option for short-term savings and/or cash that can eventually be deployed into a longer-term investment.
- Distributions accrue daily, paid monthly.

Neutral portfolio allocation¹



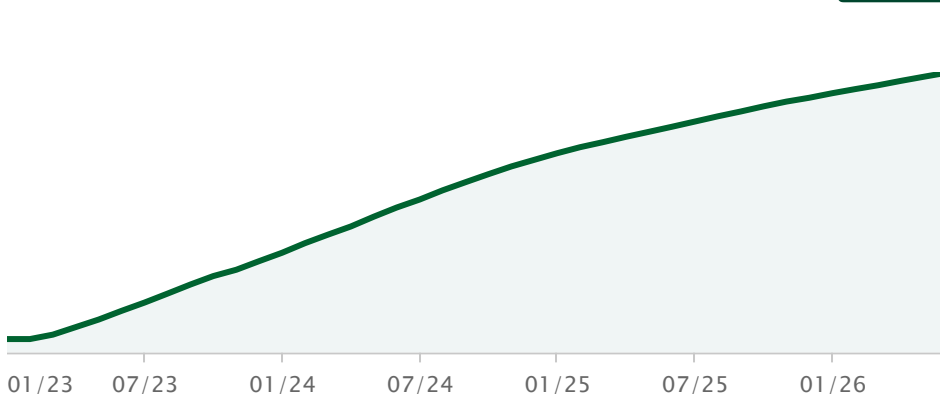

Q1 2026 Fund Commentary

Market Commentary

The first quarter of 2026 brought a volatile mix of geopolitical friction in the Middle East and a technology-driven growth narrative in the United States. The period began with optimism after the resolution of the U.S. federal government shutdown, but sentiment shifted as tensions between the U.S. and Iran escalated. Energy price volatility introduced competing forces for fixed income markets as inflationary pressure from rising oil prices weighed against the deflationary risk of a broader growth shock.

In Canada, the economic picture diverged from the U.S. as domestic fragilities became more apparent. The Bank of Canada (BoC) held its benchmark overnight interest rate steady at 2.25% in March, though policymakers adopted a more cautious tone. Data confirmed that the Canadian economy contracted in the final quarter of 2025, and the labour market showed signs of cooling, with the unemployment rate rising to 6.7% in February.

Outlook

In our view, Canada may be entering a housing-led downturn, where a combination of falling rents and tighter financing could prompt the BoC to reduce interest rates toward the middle of 2026. In the U.S., resilience in core inflation measures may limit the U.S. Federal Reserve Board's ability to ease monetary policy in the near term.
